

RECALLED Equipment and Toys

The State has brought it to our attention that we need to be very diligent about keeping recalled items from being on our sales floor. Due to liability issues and most importantly safety hazards to our children, we ask that ALL consignors check their items for recalls.

Please check all newborn/infant equipment such as strollers, mattresses, pack n' plays, play pens, car seats, exersaucers, high chairs, swings, etc. Please check for recalls on larger toys and outside playground equipment such as jungle gyms, sand boxes and inflatable items such as pools. Please check ALL riding toys including but not limited to bikes and 12-volt battery operated vehicles. Any toys that have the potential for "lead based paints" need to be checked as well as ALL toys that have an electric plug, such as easy bake ovens.

We understand that you cannot check everything, but please make an effort to check the most obvious items that could be potentially dangerous to our children. If we are visited by the State, they will remove any items from the sale that are on their recall list.

You can check for RECALLS by going to www.recalls.gov and clicking the Consumer Product icon or by visiting the home website of items by brand name such as Fisher Price, Graco, Little Tykes, etc. Most all websites will have a RECALL icon available.

In consideration for the opportunity to participate in and profit from the Little Elks Kids Consignment Sale (LEKCS) the undersigned consignor agrees to the following:

1. Consignor agrees to hold harmless and make no claim against Little Elks Pre-School, South Elkhorn Christian Church or any volunteer involved in the production of the Little Elks Kids Consignment Sale. Consignor further agrees to hold LEKCS harmless for the damage, theft, or loss of any items consigned to LEKCS. LEKCS does not anticipate any thefts, damage, or loss and will take every precaution to prevent them, but occasionally these events may occur.
2. Consignor agrees to waive any and all claims for personal injury resulting from participation in the LEKCS from whatever cause either foreseen or unforeseen against Little Elks Pre-School and /or South Elkhorn Christian Church, any volunteer of the LEKCS, or the insurer of SECC.
3. Consignors will receive 70% of the sales price on items that sell.
4. Consignor agrees that on Saturday some items may be sold for up to half of the price originally designated by the consignor if the consignor has marked Discount on the item tag.
5. **All goods left in the possession LEKCS are at the sole risk of the consignor. Consignor agrees that he/she assume and bear all risks regarding consigned goods, and will hold LEKCS exempt from any and all liability. Should items be lost, stolen, or damaged, LEKCS is not responsible to compensate the consignor for the items. _____ Initial**
6. LEKCS reserves the right to remove any items from the sale due to wear, poor condition, or stains. Items remaining after 4:30 p.m. on Saturday will be donated or become property of LEKCS.
7. Consignor agrees that no claims will be made against LEKCS for any discrepancies involving items placed in the sale.
8. Consignor agrees that unsold items marked **Donate** on the tag will be donated at the end of the sale.
9. If you do not come by during the consignor pick-up times to look through all the Merchandise that is missing tags, we will not be able to compensate you for any missing items. All merchandise without a tag that does not get claimed is automatically donated.
